CLUB MEMBERSHIP and VWPI REGISTRATION

(1st July 2011 - 30th June 2012)

REGISTRATION/CLUB MEMBERSHIP FORMS. Please find attached a copy of the new 2011/2012 combined Melbourne Collegians Club Membership and VWPI Registration form for your use. Copies will also be uploaded on to the Club website.

The Registration/Membership forms are similar to last year. You simply need to complete both Membership and Registration parts, tailor them to suit the Playing/Registration situations which best apply to you and then remit with the necessary payment to the Club Registrar for endorsement and processing. Please read the form carefully.

The Membership page comprises three sections as follows.

Section A sets the **Base Fee** associated with highest (if playing in multiple grades) or only grade you are intending to play in.

Section B sets any **Additional Fee** (game /team fees etc..) associated with the next lowest grade you are intending to play in.

Total Registration/Club Fee due is then total of the amounts you have selected in Sections A and B (if applicable).

All members must be registered to enable them to either train or play. MCWPC players cannot register directly with VWPI and registration must be via the Club Registrar.

Next Summer competition will be commencing in the week of Tuesday 2nd August. An official draw will be forwarded to your Team Manager for distribution when available from VWPI. Likely format as follows with games to be played at MSAC & MHS pools.

Division 1 Women	Tuesday nights	SL1, SL2, SL3, JnrW, YthG
Division 1 Men	Wednesday and Thursday nights	SL1, SL2, SL4, JnrM, YthB
Other Divisions	Tuesday and Thursday nights	SL2, SL3, SL5

Registrations must be in and fees paid by 30th July to ensure that you are registered in time and eligible to play at season start.

Please also note, that those intending to compete at MSAC will be required to identify themselves as water polo players before gaining entry. The most straight forward method of identification is by way of a MSAC card. Whether it is either currently charged or now expired, the card still performs this function.

If you wish to purchase a MSAC card you can do so directly with MSAC Customer Service Staff. If you do not wish to purchase a MSAC card, the Club will be issued with a generic 'Player Pass' card for use in identification but will have no function in relation to car parking, etc..

A charged card (when swiped at the boom gate) gives you access to the multi level car park. Expired cards do not activate the car park boom and you will need to take a ticket at the boom and process it at the ticket/pay station as you leave.

CLUB FEES. As with every year, there was much discussion at MC Board level over the setting of these new season fees. The following is a brief comment on that. If you have any queries, please contact Club President, Secretary or Treasurer for explanation.

Fees again have been set in order to ensure that the Club covers all water polo costs and does not incur a loss on normal operating/water polo expenses. Fundraising will still be required to ensure that other extraordinary costs (Presentations, etc..) are also adequately covered. VWPI, training and pool hire costs continue to increase and are the greatest expense the Club has to fund.

General strategy behind setting of this year's fees

- (i) Wanting to, wherever possible, limit any increase to a minimum
- (ii) To not levy any extra training fees on those who are NOT regular attendees at training. The general training fee levied provides a training opportunity to ALL members but we acknowledge that not all members elect to take a full advantage of this option.
- (iii) To maintain the 'user pay' philosophy whereby those who play multiple games in different grades and gain the most benefit from all training/coaching resources, pay appropriate fees.
